The premium will be pro-rated to coincide with the common renewal date of September 1st. You can choose any start date. Binding and confirmation of coverage will be e-mailed or mailed only once payment, in full, is received. You can select an effective date at the beginning or the end of a particular month. An effective date part way through a will count as a full month.

#### How do I arrive at Base DJ Insurance Policy Premium?

Equipment pricing is \$2.95 per \$100 value. Example \$10,000 (10,000/100 x 2.95) = \$295 in premium. Then add the number of DJ systems you would like to insure (3 x 55) = \$165. Therefore total premium is \$460.

For example, an effective date of May 15th and your property limit of \$10,000 and three systems: The \$460 premium (as shown above), divided by 12, multiplied by the 4 months to renewal of September 1st. e.g. \$460 / 12 = 38.34 x 4 months = \$154 rounded
